

Rules for the Election

- (A) The following are the posts to which election is scheduled to be held on **6th May 2023**.

| 1. President | - | 1 post |
| 2. Vice President | - | 4 posts |
| 3. Secretary | - | 1 post |
| 4. Joint Secretary | - | 1 post |
| 5. Treasurer | - | 1 post |
| 6. Executive Members | - | 4 posts |
- (B) The contestants should ensure that in the nomination forms their full name, address or contact details are legible and clearly provided including their mobile numbers.
- (C) The nomination form is attached herewith. The same has to be filled by the contestant.
- (D) The names of the proposers have to be written in capitals. The same has to be signed by the proposers and all other particulars as per the nomination form have to be filled.
- (E) One member can propose or second **only one contestant** for **one post**.
- (F) The contestant, the proposer and the second proposer and all the voting members should not have any dues as on **31st December 2022**.
- (G) Only those members who do not have any dues as on **31st December 2022** shall be allowed to cast their votes. Proxy or postal/ e-voting would not be allowed as rules of APAA do not permit the same.
- (H) New members/ members who have cleared their past dues and/or reinstated back as on 22nd April 2023 will also be allowed to Vote.
- (I) One person can fill nominations for more than one post but can finally contest only for one post i.e., if a person fills nominations for two posts, the person has to withdraw for one of the posts. If one of the nomination is not withdrawn, then both/all the nominations filed by the said member shall become invalid.
- (J) The important dates are:

Filing nomination	From 23 rd April 2023 10:00 AM onwards till 1 st May 2023 5:00 PM
Withdrawal of nomination	On or before 2 nd May 2023
Scrutiny of Nomination Papers	3 rd May 2023
Display of list of nominations on the website	4 th May 2023
Results	6 th May 2023

- (K) All the nomination forms should reach the Election Officer **Mr. Sandeep Sharma, Advocate, A-363, Defence Colony, New Delhi – 110 024** on or before **1st May 2023 by 5:00 PM**. Any nomination received by hand or by post after this date and time shall not be accepted. Those contestants who are sending their nominations by post should ensure that the nominations are delivered to the Election Officer on or before **1st May 2023 by 5:00 PM**.
- (L) The scrutiny of the nomination papers shall take place on **3rd May 2023**. Any contestant whose nomination is found incomplete shall be rejected and accordingly informed by the Election Officer either telephonically or by email. The contestants should ensure that in

- the nomination forms their full name, address or contact details are legible and clearly provided including their mobile numbers.
- (M) The list of successful nominations will be displayed on the website www.apaaindia.org on **4th May 2023**.
 - (N) In case there are more than 1 nomination for a post, election by way of secret ballot will be held on **6th May 2023** from **10:00 AM** till **1:00 PM**.
 - (O) It is mandatory to show your Photo-Identity card to the Election Officer for casting vote.
 - (P) The Election Officer will thereafter declare the result on **6th May 2023** at **4:00 PM**.
 - (Q) The decision of the Election Officer with respect to acceptance or rejection of nominations and votes shall be final.
