Rules for the election

- (A) The following are the posts to which election is scheduled to be held.

| 1. President | - | 1 post |
| 2. Vice President | - | 4 posts |
| 3. Secretary | - | 1 post |
| 4. Joint Secretary | - | 1 post |
| 5. Treasurer | - | 1 post |
| 6. Executive Members | - | 4 posts |
- (B) The contestants should ensure that in the nomination forms their full name, address or contact details are legible and clearly provided including their mobile numbers.
- (C) The nomination form is attached herewith. The same has to be filled by the contestant.
- (D) The name of the proposer has to be written in capitals. The same has to be signed by the proposer and all other particulars as per the nomination form have to be filled.
- (E) One member can propose or second **only one contestant** for **one post**.
- (F) The contestant, the proposer and the second proposer and all the voting members should not have any dues as on 31st March 2026.
- (G) Only those members who do not have any dues as on 31st March 2026 shall be allowed to cast their votes. No proxy voting would be allowed.
- (H) One person can fill nominations for more than one post but can finally contest only for one post i.e. if a person fills nominations for two posts, the person has to withdraw for one of the posts. The important dates are:

| g. Election | 18 th April 2026 from 11:00 AM to 2:00 PM |
- (I) All the nomination forms should reach the Election Officer Mr. Kunal Tandon, Sr. Advocate, X-3, Green Park, Main, New Delhi – 110 016 on or before 7th April 2026 by 5 PM. Any nomination received by hand or by post or email after this date & time shall not be accepted. Those contestants who are sending their nominations by post should ensure that the nominations are delivered to the Election Officer on or before 7th April 2026 by 5 PM.
- (J) The scrutiny of the nomination papers shall take place after 8th April 2026. Any contestant whose nomination is found incomplete shall be rejected and accordingly informed by the Election Officer either telephonically or by email/ Whatsapp. The contestants should ensure that in the nomination forms their full name, address or contact details are legible and clearly provided including their mobile numbers.
- (K) The decision of the Election Officer with respect to acceptance or rejection of nominations and votes shall be final.
